Who We Are

Information We Collect

We collect different types of information through this website including personal information from which we can identify you. We also collect information about how you use our website, our services and what interests you. This information helps us to make our services more relevant to what you want.

We will typically collect personal information such as:

- Your full name (including former name or alias)
- Your contact information (address and email address)
- Your investor relations details (including types of shares held, investor code, name under which your shareholding is held and whether you want to be contacted when we make RNS announcements)
- Other information you share with us.

We collect this information when you first register and set up an account with us or when you update your online account.

Website and Cookie Information

We automatically collect information about the use of our website and services, such as what type of device you have and which type of internet browser or mobile device you use, whether you visited our website from another website or service and your IP address (the unique reference number that identifies your device on the internet). We use industry standard Google Analytics to give us a statistical picture of how our website is used.

We also collect information using cookies. Cookies are small pieces of information stored on your browser which sometimes follow the movements of visitors on our website and tell us how our website and services are used. You can learn more about how we use cookies in our Cookie Policy.

Lawful Basis

The legal basis on which we process your personal data when you register with us is based on our legitimate requirement to communicate with all shareholders and stakeholders of the business.

How We Use Your Information

The information we collect helps us to identify you as a genuine shareholder or stakeholder of the company and helps us understand if you would like to receive electronic communication instead of paper communication from us.

My Marketing Choices

Like you, we hate spam and junk mail. We will not sell your information to marketing companies and we do not send out marketing emails.

We also understand that you might change your mind about receiving our electronic communications. If you do not wish us to continue to contact you in this way, you can either follow the unsubscribe instructions on any of our communications or go online and delete your profile.

Who we share your information with

We won't sell your information although, like most organisations, there may be cases when we need to share information.

We may share statistics about users of our website and services to help us develop our services or so that others can understand what we do. This will not include any information that identifies individuals.

We work with employees, partners and agents who are involved in delivering our investor relations services. We ensure these are covered under appropriate contractual and confidentiality protections.

If we were sold to another organisation, we may transfer any personal information we hold about you to that organisation as part of the sale or re-organisation.

We may also share information where we are required or allowed to do so by law or if we believe that this is necessary to prevent fraud or cyber-crime or to protect the site or the rights or safety of its users or any other person.

How we keep your personal information secure

We store personal information on secure servers that are managed by our service providers. These are kept in secure locations. Personal information that we store or transmit is protected by security and access controls, including username and password authentication and data encryption where appropriate.

How you can access your personal information

You can access your personal information anytime by logging into your online account on our website. You can also edit, update, correct any errors in that data as well as close the account you have with us at any time. Retention time

We will keep hold of your data indefinitely or until you choose to unsubscribe or delete your online profile.
